

RETREAT AGREEMENT

This Retreat Agreement ("Agreement") is entered into between the Guest ("Guest") and **DEBORAH MACDONALD CONSULTING** ("Company"), operated by **DEBORAH MACDONALD** for booking and participating in the PROSPERITY IN PARADISE retreat Puerto Vallarta (the "Retreat") from **JANUARY 23rd - 27th, 2025**, conducted by **DEBORAH MACDONALD**. By booking or participating in the Retreat, the Guest agrees to the following Terms and conditions. If the Guest is making a booking on behalf of other participants, the Guest guarantees that they have the authority to accept and agree to these Terms on behalf of the other participants in their party.

****BOOKING CONFIRMATION AND PAYMENT****

This booking confirmation is for **DEBORAH MACDONALD'S** Retreat in **PUERTO VALLARTA**. This is confirmed upon receipt of the following:

The **early bird prices** for the Retreat are as follows:

- A. Pay in Full \$5000 USD (private suite) \$4300 USD (shared suite) before September 30th, 2024
- B. Payment Plan 5 x \$1100 USD (private suite) or 5 x \$900 USD (shared suite) before September 30th, 2024.

The **regular cost** of the Retreat is as follows:

- A. \$5900 USD for a private suite. \$5200 USD for a shared suite.
- B. Payment Plan 5 x \$1250 USD for private suite. 5 x \$1100 USD for a shared suite.

****Early bird prices end at midnight on September 30th, 2024 EST**

****PAYMENT POLICY****

Payment must be received in full or the payment plan must be completed by January 15th, 2025, prior to the Retreat commencement (January 23rd, 2025).

If the Retreat commencement date is less than 30 days away, full payment is required to secure the booking.

If payment of the balance is not received by the due date, **DEBORAH MACDONALD** reserves the right to cancel the reservation, retain the deposit, and any payments made to date. The Guest is responsible for paying for all extra services not included in the selected Retreat package.

****TRAVEL INSURANCE****

Guests must obtain full travel insurance within 14 days of booking the Retreat, covering all medical expenses, Retreat activities, and a trip cancellation policy in the unlikely event that the Retreat is cancelled or in case of a personal emergency that prevents attendance.

Every guest must provide **DEBORAH MACDONALD** with full insurance details by January 15th, 2025.

****INCLUSIONS****

The Retreat package includes:

- a) 4 nights and 5 days of accommodation.
- b) All meals/ refreshments, including, buffet breakfast, lunch, and dinner.
- c) Airport transportation to and from the hotel.
- d) Mini branding photoshoot.

****RETREAT PACKAGE EXCLUSIONS****

The Retreat package does not include the following:

1. International or domestic airfare.
2. Optional extras and activities (activities, spa treatments or tours not listed in the Retreat package inclusions).
3. Passport (must be valid for 6 months after the departure date).
4. Mandatory travel insurance (as stated in the terms & conditions above).
5. Personal expenses for gifts.
6. Gratuity (at your own discretion).

****ROOM ALLOCATION****

The Retreat space has 6 rooms, including 2 shared suites (with double beds) for 4 people and 4 private suites (with king beds) for 4 people.

Shared rooms will be allocated at the discretion of Deborah MacDonald or based on personal requests.

****CANCELLATION POLICY****

In the event of cancellation by the Guest, regardless of the circumstances, the following refund policy shall apply:

- A. If the cancellation occurs 60 days or less before the Retreat's due arrival date, no refund will be provided.
- B. If the cancellation occurs more than 60 days before the Retreat's due arrival date and the Guest's place can be filled, a refund of 50% of the total payment may be considered at the discretion of the Company.

The Company does not offer credit or refunds for Guests arriving late or leaving the Retreat early, including due to unforeseen issues such as family-related illness, COVID diagnosis, or visa complications.

The Company reserves the right to change the Retreat's location due to unforeseen issues, such as third-party delays, problems, construction, etc. In such cases, the Company will ensure that the standards are maintained in all partnering villas/resorts.

The Company reserves the right to change or amend this cancellation policy at any time. The most current policy shall always be applicable.

****GOVERNING LAW AND JURISDICTION****

This Agreement shall be governed by and construed in accordance with the laws of Canada, specifically the laws of Ontario.

****ENTIRE AGREEMENT****

This Agreement represents the entire understanding between the parties and supersedes any prior agreements or understandings, whether written or oral, relating to the subject matter herein.

****AMENDMENTS AND WAIVERS****

No modification, amendment, or waiver of any provision of this Agreement shall be effective unless in writing and signed by both parties.

****LIABILITY****

DEBORAH MACDONALD shall not be liable for any unusual and unforeseeable circumstances beyond our normal control, which the consequences of could not have been avoided even when exercising all due care. Such circumstances or events include but are not limited to, pandemic outbreak, war or threat of war, riot, civil unrest, industrial disputes or strikes, accidents or failure to perform by third parties, including suppliers and subcontractors, unavoidable technical problems with the accommodation, transport or closure or congestion of airports, terrorist activity, natural disasters, industrial disasters, fire, theft, flooding and adverse weather conditions. In the event of any of the above, refunds and compensation payments cannot be made.

DEBORAH MACDONALD accepts no liability for loss, damage, injury or illnesses that may be received during the guest's stay or travelling to and from Deborah MacDonald's retreats. All guests must take responsibility for their own medical and physical fitness and be able to use our facilities and participate in activities.

DEBORAH MACDONALD are not liable for any injuries or losses to guests, in the use of retreat facilities or participation in activities.

While all care is taken, **DEBORAH MACDONALD** cannot accept any responsibility for the loss or damage of personal possessions or valuables of guests.

All guests must take responsibility for their own medical and physical fitness and be able to use retreat facilities and participate in activities.

This includes but is not limited to weather, noise, mosquito fogging, construction and other general activities.

****DATA PROTECTION****

The guest agrees that they may be photographed and/or filmed during her stay and/or activities in connection with the company, and also agrees that the company may use such recordings for promotion and/or advertising purposes without any prior consent. **DEBORAH MACDONALD** respects and understands the nature of the events undertaken at the retreat and will use their best efforts to respect the privacy of the guests to ensure they are not exposed personally in vulnerable situations.
